As part of this program we will automatically be enrolling your child in the 2019 Summer Day Camp Program and Afterschool 2019/2020 with the YMCA. ### **Required Items:**

- Updated wallet size color photo (A new photo is required with each new school year)
- Camp Selection Sheet
  - If camp selection sheet is not provided to the YMCA Business Center by 01/31/2019, we reserve the rate to select a camp location for your child based on availability.

Do any changes need to be made to your child's account since you last completed the online registration? If yes, then please attach the information with a copy of your photo ID.

Remember that the YMCA communicates through email regarding afterschool and summer day camp, it is your responsibility to check your email regularly and update email address changes with the YMCA Business Center, 828-251-5910 or [ymcawnc.org](mailto:ymcawnc.org).

Without written notice of cancellation by January 31, the YMCA Business Center will be re-enrolling your child in Afterschool 2019/2020 at your child's current afterschool location.

If currently receiving financial aid, through the YMCA, you will need to re-apply with your 2018 tax return (AGI). Financial Aid does not automatically roll over to a new school year.
